There will be three halls suitable for different functions and conferences. There will be ample vehicle parking area.

We earnestly appeal to you for your generous donations for this noble cause. Donors will get some concessions and benefits in the rent of the hall. The names of donors giving sizable donations will be displayed. No doubt your valuable contribution will help us to complete the Prakalpa. We shall be grateful if you use your good offices within friends and families to send their contribution to us.

We request you to send your donations payable to **“C.K.P DNYATIGRUHA TRUST, THANE”**

Home Ministry of Government of India has granted us a **registration Vide No.0833990151** to accept donations in foreign currency from **Foreign Citizens / Trusts under Foreign Contribution (Regulation) Act 1976 (FCRA)**.

**Procedure for sending the donations to CKP Trust under FCRA**

**A) For Donations by Foreign Citizens / Trusts**

- 1) All donations from Foreign Citizens / Trusts are credited only to HDFC Bank. The best way of sending donation by Foreign Citizens / Trusts is by Telegraphic remittance. There is no need for making any declaration.

If the Foreign Citizens / Trust has a Bank Account in any of the Banks in the enclosed list, he will fill the necessary remittance form of his Bank and give our FCRA saving A/C No. 01461170000021 in **H.D.F.C Bank**, Dr.Moose Road, Thane – 400602 along with Swift Code No. **HDFC INBB & IFSC Code HDFC0000146**.

However if Foreign Citizen / Trust is having his Bank Account in any other Bank or even if he has a Bank Account in any Branch of the Bank mentioned in the enclosed list, then in his remittance form he has to mention the swift code of the Bank as mentioned in the list and also mention swift code of H.D.F.C Bank as given above. In short two swift code numbers are to be mentioned in the remittance form.

The same procedure is to be followed for remittances through agencies like Times of Money Remit to India etc.

- 2) Foreign Citizens can also give their donations by Cheque in Foreign Currency. However it takes lot of time clearance, besides money loss due to commission and collection charges. Donor is also required to give his passport copy and consent letter for donation.

Hence we request you to avoid this route.

- 3) Foreign Citizen can also give donation by Cheque in INR ( Indian Rupees) by cash. He has to give Passport copy and consent letter for donation.

An Indian counterpart of this Foreign Citizen can issue his own cheque / cash but recipient Trust must have a Photocopy of the Passport and consent letter from Foreign Citizen. Then and then only the payment receipt can be issued in the name of the Foreign Citizen.

#### **B) For other Foreign Donors who are not Foreign Citizens –**

Practically the procedure mentioned in (A) above is applicable for above Donors except that they will send their donations to **Bank of India**, Panchpakhadi Branch, Thane – 400602 along with Saving Bank A/c No. **004310100004693** and Swift Code **BKIDINBBPPD** & **IFSC Code BKID 0000068**
